6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved dust/particulate filter respirator and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation. Avoid generating dust.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and sweep into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Provide adequate ventilation. Do not flush to sewer system or surface water.

7 Handling and Storage
